IT IS ORDERED THAT:

- 1. That a rule *nisi* be hereby issued, calling upon the Respondents to show cause, if any to the above Honourable Court on 26 July 2021 or as soon thereafter as the matter may be heard, why the following order should not be made final:
- 2.1 The First to Third Respondents are interdicted from mobilising, encouraging, facilitating and/or promoting any unlawful activities by its members at the various campuses of the Applicant namely; Crown Mines, Alexandra, Ellis park, Langlaate, Smit Street, Riverlea, Troyeville and Parktown, such activities to include:

2.1.1 The First to Third Respondents are interdicted from

Interfering with access to, from and the free movement on the Applicant's campuses, situated at specific CAMPUSES or any other Campus of all members of Applicant's student's community and all others who have lawful reason to move on to, off and upon the said campus.

- 2.1.1.2 Kidnapping, assaulting, threatening, intimidating or otherwise interfering in any manner with the free movement, bodily integrity and psychological and mental wellbeing, and any other constitutional rights of any members of the Applicant's students, administrative and other people who have lawful reason to be on the Applicant's campuses.
- 2.1.1.3 Disrupting, obstructing or in any other manner interfering with the academic activities

of the Applicant, which shall include but not be limited to lectures, tutorials, examinations, practical tests and use of the Applicant's library facilities and laboratories.

1.4 In any manner interfering with the academic and/or administrative staff of the Applicant while on the Applicant's campuses.

2.1 1.5 Disrupting, obstructing or in any other manner interfering with the ordinary functioning of the Applicant's residence system.

- 2.1.1.6 Causing any damage to the Applicant's property.
- 2.1.1.7 Acting in any manner, which occasions any unlawful damage to the reputation of the Applicant.
- 2.2That the orders in paragraph 2.1 above shall operate as an interim interdict with immediate effect, pending the return date.
- 2.3 The Applicant is authorised to serve process and order on the respondents by:
 - 2.3.1 Placing a copy of this Notice of Motion and Order of Court on Applicants' webpage <u>www.cjc.edu.za</u> and Student Zone Website, Applicant's Twitter Account, and Applicant's Facebook page.
 - 2.3.2 Affixing copies of this application to various notice boards at the main entrances to the Applicant's other Campuses.
- 2.4 That the applicant is hereby granted leave to supplement its founding affidavit, if necessary.
- 2.5 The Respondents are entitled to anticipate the return date after 24 hours written notice to the Applicant's attorney.



2.6 That the costs of the application are reserved for determination on the return date.
